MOTION OF AMERICAN CIVIL LIBERTIES UNION OF VIRGINIA FOR LEAVE TO FILE MEMORANDUM AMICUS CURIAE

- 1. The American Civil Liberties Union Foundation of Virginia ("ACLU-VA") is a statewide, nonprofit, nonpartisan organization with approximately 28,000 members. The ACLU of Virginia appears frequently before the state and federal courts of this Commonwealth, both as counsel and as amicus curiae. Since its founding, the ACLU of Virginia has been a forceful advocate for civil liberties and civil rights, including the constitutional rights of people accused of criminal offenses and people serving sentences of incarceration and/or community supervision.
- 2. This case raises important issues relating to the privilege against selfincrimination in the Fifth Amendment to the United States Constitution in the context of
